Rules and Regulations

Operation and Display: a) All exhibitors must be setup in the time frame given by Devotion staff. Setup time *see below, unless told otherwise. b) NO exhibitor shall dismantle their booth prior to the show being closed to the public. c) At least one representative of the company must be in attendance while the show is open to the public. d) Exhibitors will not distribute any products, signs, handouts or business cards of any non-exhibitors without written permission from Devotion management. e) All display materials and promotional literature must be in good taste. The product or service must be presented in a professional manner. f) Exhibitors are responsible for their own parking. Devotion Wedding Show has no obligations to issue parking passes or endure any cost from parking fees, tickets, etc due to the exhibitor fault.

*Setup time: Saturday 2:00pm-6:00pm and Sunday 7:30am-10:30am.

Exhibitor Space: a) Booths will be sold on first come, first serve basis. b) Booth space is outlined in the contract. Displays must not protrude beyond the measured booth dimensions, nor obstruct the aisle ways. c) Each exhibitor will be supplied with power to their booth. Extra wattage could lead to an extra charge. d) Devotion Wedding reserves the right to relocate the exhibitor booth space(s) resulting from a change in the floor plan or change in venue. Show management cannot be held liable if competitive exhibitors are adjacent to or opposite each other.

Security, Devotion Wedding Liability & Exhibitor Insurance: a) Devotion Wedding Show will not be liable for any loss or damage sustained by the exhibitor resulting, directly or indirectly, from the exhibition being closed for any reason at any time during the term of this agreement, nor shall it be liable for the loss of or injury to any property, goods or effects of the exhibitor due to any cause whatsoever. b) Any loss, damage(s), injury or cost whatsoever suffered by the exhibitor by reason of any change in the date, time or place of exhibition or the abandonment thereof. c) No photographs and videotaping is permitted of any exhibitors booth but your own. d) If Devotion management should be prevented from holding the show by any cause beyond its control or if it cannot permit the exhibitor to occupy their rented space due to circumstances beyond its control including but not limited to strike, fire, civil disobedience, inclement weather, lockouts, acts of god, suppliers, etc. Devotion management shall have no further obligation or liability to the exhibitor.

Confidential Bride List: a) The brides list will be comprised of information collected from ballot information. b) Within two weeks following the show the brides list will be made available. The content of the bridal list is strictly confidential and all exhibitors are subject to the Federal Confidentiality Regulations.

General: a) All matters and questions not covered by these rules and regulations are subject to the decision of Devotion management. b) The exhibitor agrees to abide by all decisions of Devotion management and further agrees to cease any activity that the Devotion management deem to be in violation of the terms and directives of Devotion Wedding. c) The exhibitor shall be solely responsible for all acts or omissions due to or caused by the negligence or willful misconduct of their employees or agents at any time while the exhibitor is in occupation of the booth or any portion thereof and will indemnify Devotion Wedding from any and all such claims and losses. d) Devotion Wedding shall not be liable for any damage or injury caused to a member of the public or any third party by reason of the negligence or willful misconduct of the exhibitor, its agents or employees and will indemnify Devotion Wedding from any and all such claims and losses. e) The exhibitor shall be responsible and shall secure, at its own expense, any liability insurance which it may require to protect itself from any damage or injury referred to in Security, Devotion Wedding Liability & Exhibitor Insurance.

Door Prizes: The winner will have 7 days (one week) from show date to pick up door prize. There are no substitutions, cash value or exchanges on door prizes. Devotion Wedding does not assume any responsibility for any prizes or other gifts awarded by the exhibitors to the customer. The exhibitors agree to indemnify Devotion Wedding for any legal cost associate with defending any legal suit or other claim which may be brought against them by the customer.
